The Central Board of Secondary Education (CBSE) is going to conduct the Direct Recruitment Quota Examination 2026 (DRQ2026) in accordance with Advertisement No. CBSE/Rectt.Cell/14(88)/2025 dated 02nd December 2025.

After the closing date for receipt of online applications, i.e., 27th December 2025 (11:59 PM), candidates will be provided a two-day edit window, as per the schedule given below, to enable candidates to correct or modify any incorrect particulars filled by them in the online application form.

Duration/Dates for Correction in Particulars

29th December (Monday) 2025 and 30th December (Tuesday) 2025 (upto 11.59 pm)

Important Instructions:

- 1. Only those candidates who have successfully submitted their completed online application form along with payment of the requisite fees within the stipulated period of application registration will be allowed to make corrections.
- 2. This is a **one-time facility** provided to candidates to avoid hardship. Candidates are therefore advised to make corrections **very carefully**, as **no further opportunity for correction will be provided**. The details are as follows:
