



IMPORTANT NOTICE

PHYSICAL ENDURANCE AND MEASUREMENT TEST (PE&MT) OF THE SHORTLISTED CANDIDATES FOR RECRUITMENT TO THE POSTS OF CONSTABLE (EXECUTIVE), CONSTABLE (DRIVER), HEAD CONSTABLE (MIN.), HEAD CONSTABLE (AWO/TPO), IN DELHI POLICE EXAMINATION-2025.

The Physical Endurance and Measurement Test of all the shortlisted candidates for the posts of Constable (Executive) Male & Female, Constable (Driver), Head Constable (Min.), Head Constable (AWO/TPO), in Delhi Police Examination-2025 **is likely to commence from 25.07.2026 (Saturday)**. All shortlisted candidates are advised to get prepared accordingly and read carefully the following instructions for strict compliance:-

1. Candidates **must bring their e-Admit Card**. A link to download the e-Admit Card will be made available on the official website of Delhi Police i.e <https://delhipolice.gov.in/recruitments> .
2. Candidates must bring ten (10) recent passport-size-colored photographs and at least one clear photo identity proof showing their complete date of birth, failing which, they shall not be allowed to appear in the PE&MT. Acceptable identity proofs are as follows:
 - a. Passport
 - b. Aadhaar Card
 - c. Driving License
 - d. Service Identity Card (for Ex-servicemen/Government Employees)
 - e. Identity Card issued by a University/College/School
 - f. Voter ID Card
 - g. PAN Card
 - h. Ex-serviceman Discharge Book issued by the Ministry of Defence
 - i. Any other photo identity card issued by the Central or State Government
3. Candidates must bring the **originals** of all applicable documents, such as educational certificates, caste certificate, EWS, Driving License, hill area certificate, sports certificate, Delhi Police ward certificate, departmental candidates certificate, NCC certificate, RRU certificate etc. along with **one set of self-attested photocopies** of all documents.
4. No benefit or relaxation will be granted without the original document, and the candidate will be marked as **disqualified. No additional time or extension will be given to produce the original documents.**

5. Candidates seeking reservation under the **SC/ST/OBC/EWS** categories must ensure that they are eligible for such reservation on the **crucial date as per notification**. They must produce caste/community certificate at the time of PE&MT. The certificate **must be in the format prescribed in the Annexure** of the notification for the post concerned. **Certificates in any other format except published in the notification will not be accepted.**
6. For the post of **Constable (Executive) (Male only)**:- Candidates must possess a valid **LMV Driving License** (Motorcycle *or* Car) on the date of PE&MT. **A Learner's License will not be accepted.**
7. For the post of **Constable (Driver)**:- Candidates must possess a valid **Heavy Motor Vehicle (HMV) Driving License** issued on or before the closing date for submission of the online application i.e. **15.10.2025**.
8. Ex-Servicemen (ESM) candidates who are currently serving must produce a **No Objection Certificate (NOC)** which shall clearly mention their date of discharge from the armed forces in the prescribed format as per the Annexure of the notification. Candidates who have already been discharged from the Armed Forces must produce their **Discharge Book/Discharge Certificate** along with the prescribed undertaking.
9. For the post of **Constable (Executive)**, Ex-Servicemen (ESM) :- candidates applying under the Special Category (Commando) must produce the relevant certificate as applicable showing that they:-
 - a. having served in the Special Forces/NSG (Special Action Group); or
 - b. having received a QI (Qualified Instructor) grading in the Commando Course; or
 - c. officers from the Navy or Air Force who have served in specialized commando-type units.
10. The female candidates, who are either pregnant, or gave birth to a baby or have miscarriage at the time of PE&MT, may not be allowed to participate in Physical Endurance Test and shall be declared **temporarily unfit** until the confinement period is over, as mentioned in the notification. Such candidates shall submit an application along with medical documents in this regard on the scheduled date/venue of PE&MT.
11. No request for a change in the **date, time, or venue** of the PE&MT will be entertained. Candidates who fails to appear on the scheduled date, time & venue will be treated as **ABSENT** and no request for another opportunity, whether submitted by post, by hand, email, or any other mode will be considered/entertained.
12. Candidates are advised to ensure that they fulfil all the eligibility conditions and

meet the prescribed PE&MT standards mentioned in the notification for their respective post available on the SSC website: <https://ssc.gov.in>.

- 13.No travelling allowance or any other expenses will be paid by Delhi Police for attending the PE&MT.
- 14.Delhi Police shall not be responsible for any accident or injury/loss that may occur during the PE&MT and shall not be liable for any claim arising out of such accident or injury.
- 15.The candidates who qualify in the **Race** will be eligible to participate in the further events i.e. **Long Jump** and **High Jump**. Candidates will be provided with **three attempts** to qualify the Long Jump and High Jump. No appeal against disqualification in the Race, Long Jump and High Jump will be entertained.
- 16.The **Physical Measurement Test (PMT)** will be conducted only for those candidates who qualify in the **Physical Endurance Test (Race, Long Jump and High Jump)**.
- 17.Candidates are advised **not to bring any** valuables, firearms, sharp objects, mobile phones, or any electronic gadgets to the PE&MT venue. Delhi Police will not be responsible for the loss of any personal belongings.
- 18.Any candidate found involved in any malpractice will be disqualified forthwith.
